<u>Uploading evidence - file format</u>

Uploading evidence for application for determinations

When submitting an application for a Determination please note the following.

- The file format of the application needs to be confirmed and submitted in the system prior to uploading.
 For example: if the evidence is in ".pdf" format, the evidence will need to be
- uploaded and confirmed in the system in the same file format. If the evidence is in ".docx" format, you will need to upload and confirm the same file format. If an incorrect file type is selected DHS will be unable to view the evidence uploaded, which may result in the application being rejected.
